Terms of contract

We work exclusively **on the basis of the current ADSP.**

For cross-border transports we work **on the basis of CMR freight law.**

By accepting the order, you confirm that you have all the necessary permits and licenses for the transport (including the Minimum Wage Act - MiLoG). When passing the transport order to subcontractors, permits and licenses must be present and the minimum wage law must be observed.

In case of failure to comply with this freight order, a replacement vehicle must be provided or the cost difference to the replacement vehicle, as well as 50,00 Euro handling fee must be paid.

Deadfreight and demurrage charges

The agreed freight includes a **loading and unloading period of 2 hours each**. If the loading and unloading period is exceeded, the carrier is entitled to **demurrage charges of 50,00 Euro per each additional hour**.

A delay in loading or unloading the vehicle, must be reported to Cargoboard no later than after one hour of waiting time. If the delay is not reported in time, the claim may expire or be reduced.

The **deadfreight** for loss of assignment in case of same-day cancellation of the transport order or other reasons shall amount to a **maximum of 75% of the agreed freight**. Deadfreight, demurrage and other compensation are limited to a **maximum daily rate of 700,00 Euro**.

Pallet exchange

If the exchange of pallets is agreed in the contract, the carrier shall ensure the exchange of EUR-pallets and EUR-pallet-cages. The exchanged and not exchanged pallets must be noted on the freight documents.

The carrier has to check the exchanged pallets for completeness and externally visible damages.

Pallets that have not been exchanged will be charged with 25,00 Euro per piece if they are not returned within a period of 14 days after the execution of the transport order, free of charge.

Corresponding receipts and documentation must be submitted immediately.

Customer protection

Transportation is carried out on behalf of Cargoboard and customers are contacted only by us, unless otherwise agreed in advance (for example, by avis).

Invoicing formalities

Payment of freight will be made within 21 days upon receipt of the invoice.

An invoice sent by postal mail will not be accepted and will be promptly rejected by us.

If the invoice is sent to a different email address of ours, timely payment is not guaranteed.

The invoice must contain the **transport order number** of the executed order and will be rejected by us without it.

Please also provide the **contact details of your accounting department (especially the email address)** on the invoice.

* The carrier can add additional 10,00 Euro to the invoice amount if following conditions are met.:

1.) Status updates have been entered completely and timely into our system (button in the transport order).
2.) Proof of delivery (POD) has been uploaded in the system within one working day after delivery (For now, a photo of the proof of delivery, is sufficient if it is subsequently provided as a scanned copy).
3.) Invoice has been uploaded in the system within 7 days after delivery.

If the afore mentioned conditions have **not been met**, we kindly ask you to **not** charge the additional 10,00 Euro as a bonus. Such invoices will be **rejected** by us and must be corrected afterwards, which entails additional effort for all parties involved.
