Terms and Conditions for the transport order:

- At the loading and unloading place please sign up with the corresponding reference numbers on behalf of EP Logistic GmbH.

- The driver has to wear safety shoes and a safety waistcoat at the loading and unloading place.

- The vehicle must be in a sound, clean, dry, odorless and roadworthy condition. The driver must have all permits

and certificates necessary for the particular transport. Driving and rest periods must be respected.

- If production problems occur or other circumstances which lead to failure of the cargo, a maximum credit load 1/3 of the agreed freight charges; maximum 350 € is accepted.

- If we ourselves cancel loads until 17:30 the previous day they can generally not be charged.

- In case of any delay during the transport process we must be informed immediately. Especially if fix

appointments are not kept we reserve our right to subtract a contract penalty of 250 € from the freight.

– 3 hours each free for loading and unloading. Each additional hour will be paid with 35 \in

(max. 300 € per day). If any problem occurs at the loading or unloading site we have to be informed in written form within 60 minutes. It must be kept record of any waiting time by the loading or unloading place on the CMR or on a similar document.

- Loading and unloading is only possible from the back! No loading and unloading is possible from the side.

- Upon instructions from the loading or unloading point, the driver must load or unload himself. This is already included in the freight price with €25 each.

- You confirm that the relevant legal guidelines, ordinances on transport and proper handling of the goods and on all areas that come into direct or indirect contact with the goods are observed. Furthermore, you confirm the following requirements of IFS Logistics 2.2, where applicable: 4.1) General requirements for storage and transport / 4.3) Transport / 5.3) Calibration, adjustment and checking of measuring and monitoring devices / 6) Product/food defence plan and external inspections.

In the case of subcontractors, you also ensure compliance with the above points. In the event of a deviation from one of the above points, you undertake to notify EP Logistic GmbH in writing. All information is binding until a revised version is available. EP Logistic GmbH reserves the right to view or request evidence.

- Transports of food, packaging and sanitary Products can only be mixed with merchandise on pallets - any additional load of chemical products, glass (including glass packaging), fresh/living plants, machines, varnishes, colours or other food jeopardizing material is prohibited.

- The quantity and type of cargo must comply with the documents. If any difference to our transport order arises

we have to be informed in written form before the truck leaves (in particular discrepancies in quantities or

addresses on documents).

- If tilt trucks are agreed in transport order, these must necessarily be equipped with 32 aluminum side boards. In

case of violation, we reserve our right to impose a fine of 250 € and charge them up against outstanding debts!

- Temperature-controlled transports have to be accomplished in strict compliance with the dictated temperature.

The trailer must arrive at the loading place with the agreed temperature pre-cooled or heated.

Temperature data recorder are required for frozen cargo. Temperature logs have to be kept for 2 years and

surrendered on demand. The temperature data logger must be calibrated and maintained regularly. A proof has to be surrendered on

demand. The vehicle used must have a valid FRC certificate. A proof has to be surrendered on demand. - If pallet exchange has to take place "Cologne pallet exchange" has been agreed. If pallets cannot be changed, you

must obtain instructions from us immediately before the truck leaves. Otherwise we will charge you € 14,00 per pallet. We will also charge

a processing fee of €25. This will not be refunded. You agree to balance against the open items by accepting the transport order.

- Customer protection has to be respected. If it is not respected we will hold you responsible and claim a penalty

fee of 10,000 €.

- Without our explicit permission it is prohibited to sell the transport to other sub-contractors (particularly with the help of freight exchanges). In case of violation we reserve our right to cancel the transport order at any time without payment of any compensation.

- If your truck does not arrive in due time at the loading site, we reserve our right to hire a replacement vehicle and charge you with the extra costs.

- In opposition to HGB § 431 for national transports a maximum exposure of 40 SZR is agreed.

- To settle your account an originally signed and stamped proof of delivery is required.
